A self declaration by the self-employed parents/guardians, stating definite income from all sources by way of an affidavit on non-judicial stamp paper. Employed parents/guardians are required to obtain income certificate from their employer and for any additional income, from other sources, they would furnish declaration by way of an affidavit on non-judicial stamp paper.
4. One attested copy of certificates, Diploma, Degree etc. in respect of all examination passed
5. One copy of the passport size photograph of the student thereon.
