## NOTE:

1. Scholarship shall be awarded for one academic year.
2. Scholarships shall be awarded to the students whose parents' gross income should not exceeds Rs. 5.00 lakhs per annum.
3. A student admitted during 2012-13 should obtain a CGPA of at least 7.00 for continuing the merit-cum-mean scholarship. The student admitted in 2013-14 onward should obtain a CGPA of at least 6.00 for continuing the scholarship. The income criterion should also be satisfied for the continuation.
4. Girls students coming from families have no male child will be given preference.
5. The information provided by the applicant for availing the merit-cum-means scholarship can be verified by the committee at any point of time. If any information found false, scholarship will be withdrawn and disciplinary action will be taken against the student.
6. The right of awarding the merit-cum-means scholarship shall lie with the award committee.

**Students applying for Merit-cum-means scholarship will attach the following certificates/documents:**

1. JEE (main) Rank for BE 1<sup>st</sup> year student, Merit No. for ME/MTech/MSc./MCA/MBA 1<sup>st</sup> year student. AGPA & CGPA in case of other students, of last examination passed.
  2. Proof of annual family income in the form Income Certificate issued by revenue official /copies of Income Tax returns for last three years filed by the parents.
  3. The parents shall be required to submit an affidavit of their immovable property duly verified by the notary.
  4. For availing only girl child benefit, parents are required to submit an affidavit for having girl child only duly verified by the notary.
  5. A copy of fees receipt paid by the student for current semester.
