**NOTE:**

- I. Five scholarships to each of the five deserving meritorious **Bachelors of Engineering female students** admitted to four year Bachelors of Engineering program in the year 2019 (**one each from Computer Engineering, Electronics and Communication Engineering, Electronics and Computer Engineering, Electrical Engineering and Civil Engineering**) shall be paid each year to cover the expenses towards their tuition fee, development fee, hostel fee, for a period of four years.
- II. The first instalment of scholarship shall be awarded to each of the five students admitted in the year 2019 and it shall continue to be given to each one of them for a period of four years, every year.
- III. The criteria for eligibility for the Scholarship are as follows:
  - a. The total annual income of the Applicant's family should be less than or equal Rs. 8,00,000/- (Rupees Eight Lakh Only);
  - b. Income Tax Return forms of the last three years of the parents should accompany with application. In case where parents are self employed or not filing IT returns then Income Certificate issued by the revenue official, not the rank less than Tehsildar, shall only be considered.
  - c. The parents shall be required to submit an affidavit duly verified by Notary regarding their immovable property and also stating source(s) of annual family income from all the sources.
  - d. The Applicant must have secured a minimum of a total of 75% at the 10+2 (ten plus two) level examination;
  - e. The Applicant must have also secured a minimum requirement in the Joint Entrance Examination;
  - f. The candidates with least family income among the applicants will be given preference;
  - g. To continue this scholarship, a student has to score CGPA  $\geq$  7.0 with no E or F or X grade in relevant academic year.
- IV. The complete scholarship scheme is mentioned in the TIET Prospectus for 2019-20 under scholarships / Tuition Feeships at Sr. No. 25.6.
- V. The information provided by the applicant for availing the scholarship can be verified by the committee at any point of time. If any information found false, scholarship will be withdrawn and disciplinary action will be taken against the student.
- VI. The right of awarding the scholarship lies with the award committee.

**Students applying for BOOKING.COM Scholarship will attach the following certificates/documents:**

1. JEE (main) Rank for BE 1<sup>st</sup> year student and CGPA in subsequent years.
2. A copy of DMC of 12<sup>th</sup> class and proof of score in JEE Main.
3. Proof of annual family income in the form of Income Certificate issued by revenue official not less than rank of Tehsildar /copies of Income Tax returns for last three years filed by the parents.
4. An affidavit by the parents duly verified by the notary regarding their immovable property and also stating the source(s) of family annual income.
5. A copy of fees receipt paid by the student for current semester.
6. A copy of pass book of student bank account /cancelled cheque / bank statement.
